RHODDIR DRWY HYN RYBUDD fod Cyngor Gwynedd wedi gwneud Gorchymyn sydd yn gwahardd unrhyw berson rhag peri i unrhyw gerbyd fynd mewn unrhyw gyfeiriad ar hyd y darnau hynny o'r Ffyrdd Ddi-Ddosbarth a adwaenir fel Balkan Hill a Hopeland Road, Aberdyfi o bwynt ger Sŵn y Wylan, Balkan Hill, gan deithio mewn cyfeiriad de ddwyreiniol hyd at ei gyffordd gyda Church Street, Aberdyfi yn ogystal â Hopeland Road o bwynt ger ei gyffordd gyda Balkan Hill, gan deithio mewn cyfeiriad gogledd ddwyreiniol hyd at bwynt gyferbyn â Llwyn Onn, Hopeland Road, Aberdyfi.

Mae angen y Gorchymyn ar sail iechyd a diogelwch i'r cyhoedd yn ystod cyfnod gwaith cloddio ac adfer ffos am oddeutu 55 metr o fewn y gerbyffordd ar gyfer cysylltiad gwasanaeth.

Y ffordd arall o bwynt ger ei gyffordd gyda Church Street yw troi i'r dde ac yna dilyn y ffordd ymlaen mewn cyfeiriad de orllewinol hyd at ei gyffordd gyda Copperhill Street. Troi i'r dde, ac yna ymlaen mewn cyfeiriad gogledd orllewinol, heibio Tai Newyddion, hyd at ei gyffordd gyda Trem Leri. Troi i'r dde, gan ddilyn y ffordd ymlaen mewn cyfeiriad gogledd ddwyreiniol ac yna ymlaen ar hyd Mynydd Isaf hyd at ei gyffordd gyda Balkan Hill ac yna troi i'r dde, gan ddilyn y ffordd ymlaen hyd at y caead.

Daw'r Gorchymyn i rym ar y 10fed o Ionawr, 2022 a bydd yn parhau mewn grym am gyfnod na fydd hwy nag un mis neu hyd nes y cwblheir y gwaith y bwriedir ei wneud ar y ffordd, pa un bynnag fyddo gyntaf. Ar hyn o bryd disgwylir y gellir cwblhau'r gwaith o fewn tua 18 diwrnod.

**ROAD TRAFFIC REGULATION ACT 1984
SECTION 14(1) AS AMENDED BY THE ROAD TRAFFIC
(TEMPORARY RESTRICTIONS) ACT 1991**

**THE GWYNEDD COUNCIL
(CLOSURE OF THE UNCLASSIFIED ROADS KNOWN AS BALKAN HILL AND HOPELAND
ROAD, ABERDOVEY)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that the Gwynedd Council have made an Order, the effect of which is to prohibit any person from causing any vehicle to proceed in either direction along those lengths of Unclassified Roads known as Balkan Hill and Hopeland Road, Aberdovey from a point near Sŵn y Wylan, Balkan Hill, travelling in a south easterly direction up to its junction with Church Street, Aberdovey in addition to Hopland Road from its junction with Balkan Hill, travelling in a north easterly direction up to a point opposite Llwyn Onn, Hopeland Road, Aberdovey.

The Order is necessary on health and safety grounds to the public during excavation work and the reinstatement of a trench of approximately 55 metres in the carriageway for service connection.

The alternative route from its junction with Church Street is to turn right and follow the road in a south westerly direction up to its junction with Copperhill Street. Turn right, and then proceed in a north westerly direction, passing Tai Newyddion, up to its junction with Trem Leri. Turn right, following the road in a north easterly direction and then along Mynydd Isaf up to its junction with Balkan Hill and then turn right, and continue along the road up to its closure.

The Order comes into effect on the 10th January, 2022 and will continue in force for a period not exceeding one month or until the work which it is proposed to carry out on the road is completed, whichever is the earlier. At this stage it is anticipated that the work will be completed within approximately 18 days.

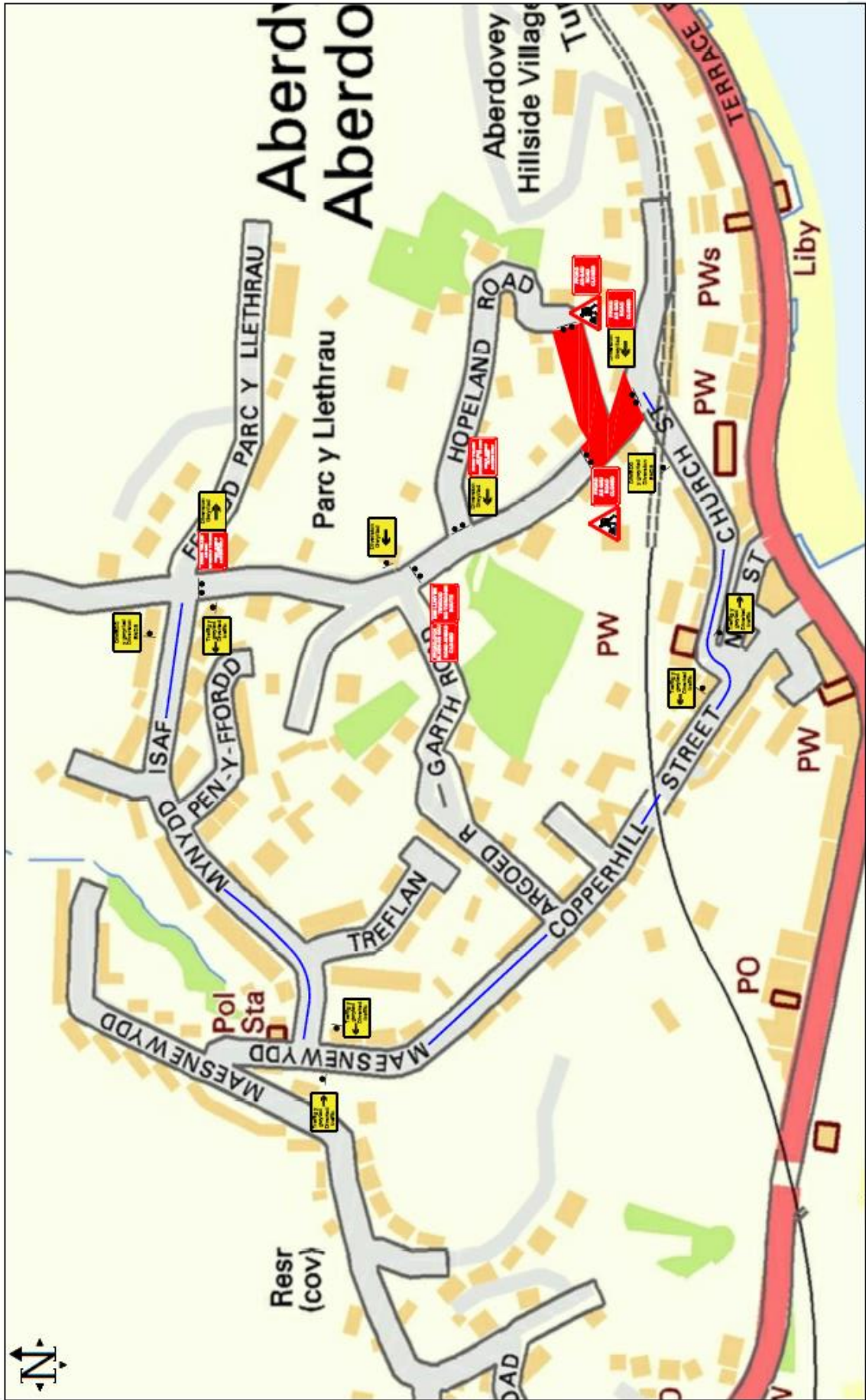
