**Introduction and Context**

Aberdyfi Community Council serves approximately 700 resident and our precept for 2025 – 2026 is £45,546. We provide a range of services which impact on local diversity, including:

\* Responsibility for the playing field by the Neuadd Dyfi, which contains a football pitch, and various small green spaces in the village eg. round the edge of the Neuadd Dyfi car park.

\* Responsibility for the maintenance and upkeep of some footpaths and the bus shelter by the Neuadd Dyfi.

\* Organising planters throughout the village and a planted area in the centre of the village.

\* Support – we give grants and support to local groups who want to positively impact biodiversity.

We promote sustainability and biodiversity by pursuing sustainability practices whenever possible.

## Review of s6 duty

- **What has worked well?**

The continuation of the planted area in the centre of the village and planters have proved a great success, especially as it has proved attractive to residents in addition to helping biodiversity. They have also encouraged residents to volunteer to look after these areas, such as weeding, pruning, watering planters etc.

Working with SNPA and Gwynedd Council is ongoing and relations are good, with representatives being keen to work together, however, Gwynedd did not keep to their commitment of planting wildlife verges in the village. Parc Eryri have been helpful in identifying which type of plants to purchase.

Groups of volunteers coming together to create and improve biodiversity, who have been encouraging other people to becoming involved and also volunteer.

Volunteers stepping up to look after other small areas in the village, such as around the Neuadd Dyfi and by the toilets next to the Neuadd.

We have adopted a process of trying to ensure that work is given to local contractors, thus reducing carbon footprint.

- **What have the barriers been?**

The Places for Nature Wildlife garden has not worked as well, with residents volunteering to look after it, but not keeping to the commitment.

Lack of expertise to identify changes needed / possible or best practice.

- **What will you change?**

Try to work more closely with experts at SNPA, Gwynedd Council and local experts to seek advice

Seek and encourage volunteers to look after the wildlife garden

Work with Gwynedd Council to plant wildlife verges rather than grass

Encourage residents to engage and provide ideas for increasing biodiversity.

- **How and when will the s6 duty be monitored and the s6 plan reviewed?**

The duty will be monitored by the Council and individual councillors will report on anything that can be improved or needs attention.

The s6 plan will be reviewed in light of these reports and any other information that is made available to the council from volunteers etc. The plan will be reviewed annually.
